### Overview of Company

### Job Description

The Monitoring Lead will monitor project activities through an Indigenous-led land-based Environmental Monitoring program in a manner that respects inherent rights, treaties, land management systems and principles. This position will support the George Gordon First Nation Climate Planning Action project through environmental monitoring activities, administrative tasks, and event planning associated with deliverables of the project.

The Monitoring Lead will, work with the assistance from the project team, youth, land harvesters and elders to incorporate Traditional stewarding methods when dealing with natural environment. The successful candidate will be part of a team that integrates Indigenous knowledge with western approaches that provides information to the community. They will work on the development of a monitoring program that meets the community's expectations and best monitors/protects their homelands. Work is performed in a mix office and field environment. Office work will consist of planning and reporting on project activities, while field work will be data gathering, sampling, taking photographs of environmental features, health assessment of the land, and to meet with communities.

The Monitoring Lead will report to the Project Lead and will always represent WLCS in a professional manner. Since WLCS is a George Gordon owned company, the ideal applicant would have some post secondary schooling, a member of one of the four Touchwood Hills bands and have access to a vehicle.

### Responsibilities

- Involve the Indigenous population in the ongoing monitoring of the project.
- Support WLCS team in the development and implementation of an Indigenous-led Environmental Monitoring sessions and programs.
- Coordinate the involvement of Indigenous Knowledge Holders into project construction, operation, and monitoring activities.
- Lead and direct Interns to complete daily tasks, field work and reporting.



- Work with GGFN to understand their expectations of monitoring the homelands.
- Develop reports, briefings, and workshops that are related to environmental activities.
- Record data and observation in an accurate and well-organized manner.
- Read maps and navigate variable terrain, including operating vehicles.
- Assist with preparing technical reports detailing monitoring activities.
- Communicate effectively with project team members.

#### Other Duties

- Participate in meetings as required.
- Report and assist the Project Lead.
