Reporting to the Surveillance Officers the Surveillance Monitor is responsible for monitoring SaskGaming's properties to ensure the safety of staff and guests, protect corporate assets, maintain gaming integrity and perform audits for procedural compliance.

**Please note: Surveillance employees may not transfer to Gaming positions on the casino floor or any other position requiring the handling or escorting of casino funds in the same casino after leaving the surveillance department. Gaming positions, on the casino floor, are defined as any position within the Bank/Cage, Live Games, Slots/VLT and Security departments.**

### Qualifications:

Candidates must have a minimum of Grade 12. Preference may be given to candidates who possess experience in monitoring gaming activities. An acceptable combination of education and experience may be considered.

You must be willing to work different shifts which include evenings, nights and weekends. You must be legally entitled to work in Canada.
