## Access to Campus and Services

Please read these Terms and Conditions ("Terms," "Terms and Conditions") carefully before visiting a First Nations University of Canada (FNUniv) Campus. First Nations University of Canada Re-Open Plan will ensure the health and safety of students, faculty, and staff, with the direction, guidance, and orders from the Saskatchewan Health Authority (SHA) and Government of Saskatchewan Chief Medical Officer.

Your access to a Campus and use of any Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all students, visitors, and others who access a Campus or use the Service.

**By accessing a Campus or using the Service, you agree to be bound by these Terms. If you disagree with any part of the terms, then you may not access a Campus or any on-campus Service.**

### **USER GUIDELINES:**

As a condition, you agree to adhere to all requirements before the use of Services for any purpose.

#### **Before accessing a Campus:**

1. Must use the assigned entrance at a Campus and use the assigned exit.
2. Must wear a mask before entering a Campus.
3. Everyone must check-in at the designated location. A Surveillance Screener will ask you the questions on the Screening Form, along with your contact information. The Screening Form is used for contact tracing purposes.

#### **After access is permitted:**

1. Maintain social distancing and practice of proper hygienic practices is required while on a Campus.
2. Must wear a mask for the duration of time on a Campus.
3. Hand sanitizer is available throughout a Campus.
4. Follow all directional signs and notices on a Campus.
5. Students who have a confirmed booking through the Online Booking System, after completing the initial steps, will go directly to the workstation and or lab assigned.

6. When your scheduled booking time has ended, please exit a Campus as the cleaning & disinfecting process will proceed immediately.
7. Regina Campus – students will have access to Main Floor only. Access to other floors must have prior approval.

If you do not adhere to the Terms & Conditions, you will be asked to leave a Campus.

We reserve the right to modify or remove these Terms & Conditions for any reason, at our sole discretion, without notice.
